

1. The quotations for the vehicle should be given as per Annexure in a sealed cover.
2. The envelope enclosing quotation should be superscribed "Quotation for Hiring vehicle for official purpose in Kerala Forest Headquarters, Vazhuthacaud, Thiruvananthapuram - 695014.
3. The quotation should be addressed to **The Assistant Conservator of Forests & Estate Officer", Forest Head Quarters, Vazhuthacaud, Thiruvananthapuram - 695 014"**.
4. The quotation should reach the office of Estate Office, Forest Headquarters, Vazhuthacaud before 3 PM on 21/02/2026.
5. The quotations will be opened at 4 PM on 21/02/2026. The quotation or representatives thereof can attend the quotation opening session at the scheduled time.
6. Contractor/Owner shall provide 2 Nos of Sedan Vehicles (Swift Dzire/ Honda Amaze/ Maruthi Ciaz/ Toyoto Etios or equivalent) **which are not more than 5 years old in excellent condition.**

7. Insurance and Taxes any other statutory requirement shall be the responsibility of the Contractor/ Owner.
