The Directorate of Forest Education proposes to conduct one week (6 days) **General Refresher Course for in-service State Forest Service Officers/Sr. Forest Range Officers at Central Academy for State Forest Service, Coimbatore during the financial year 2017-18.**

The Assistant Conservator of Forests/Sr. Forest Range Officers who have put in a minimum of three years service and are below fifty four years of age are eligible for nomination for the above mentioned General Refresher Course provided they have not undergone the same training earlier under the Directorate.

You are requested to nominate suitable SFS Officers/Sr. Forest Range Officers of your State for the General Refresher Course as CASFoS, Coimbatore as per the table given below. The officers may be directed to report at the Academy a day in advance of the scheduled beginning of the General Refresher Course. The seats are allotted to your state in the General Refresher Course are as under:-

In the past there has been less than desired level of participation of ACF officers/Sr. FROs from your state and one of the reasons cited by the participation was delay in nomination at Principal Chief Conservator of Forests level. Therefore, it is requested that the nomination for all the courses mentioned in the above table be made at one time and communicated to the Directorate and Principal, CASFoS, Coimbatore so that the Officers could be contacted directly to facilitate their trainings.

Moreover it is also requested to communicate the name of a nodal officer in your office who could be contacted for further action in this regard.

While nominating the SFS Officers/Sr. FROs for the above General Refresher Course, Principal, CASFoS, Coimbatore may also be informed immediately the name, telephone number and address of the nominated officers.

The workshop is residential and expenses towards boarding and lodging of the participants shall be met by the Government of India and Travel expenses of the participants shall be born by the State Government.
