As per the direction of Election Commission of India, postal ballot has to be issued to the absentee voters (who are not able to be present in their respective polling station on the day of poll) belonging to the category of essential services of the state (Category -AVES). The Chief Electoral Officer vide reference 1<sup>st</sup> cited has requested to appoint one Nodal Officer at district level from Forest Department to coordinate with the District Election Officer (District Collectors) facilitating them to issue postal ballot to the above electors.
