In continuation of the letter read 2<sup>nd</sup> above, I am enclosing herewith  
copies of two letters received from Government vide reference 3<sup>rd</sup> above,  
wherein Government has reiterated that, AIPR for the year 2022(as on  
01.01.2023) is required to be filed by all IFS officers online, in the IPR Module  
available in SPARROW portal i.e, [www.sparrow-ifs.eoffice.gov.in](http://www.sparrow-ifs.eoffice.gov.in), latest by 31<sup>st</sup>  
January, 2023 and further informs that, IPR in any other form will not be  
accepted. It is also informed by Government that, **Vigilance Clearance** shall  
be denied to an officer who fails to submit his/her AIPR by 31<sup>st</sup> January of the  
following year and also that, filing of IPR is made mandatory for being  
considered for appointment to the next level of pay matrix.

Accordingly, all IFS officers are strictly directed to file their AIPR for the  
year 2022(as on 01.01.2023) in online mode, **before 31<sup>st</sup> January 2023,**  
**without fail.**

2022 (as on 01.01.2023) in SPARROW portal by Indian Forest Service  
(IFS)- Officers reg.

Sir,

The undersigned is directed to refer to DoPT's D.O. No. 6(4)/2022-EO(PR) dated 19.12.2022 (copy enclosed) for online filling of AIPR by IFS officers and to say that "Rule 16(2) of AIS (Conduct) Rules, 1968 provides that every member of the Service shall submit an annual return in such form as may be prescribed by the government in this regard, giving full particulars regarding the immovable property inherited by him or owned or acquired by him or held by him on lease or mortgage, either in his own name or in the name of any member of his family or in the name of any other person".

2. This Ministry has already developed software to facilitate the Indian Forest Services (IFS) officers to file their Annual Immovable Property Returns (AIPR) online. Accordingly, every IFS officer is required to submit his/her AIPRs online on SPARROW portal i.e. www.sparrow-ifs.eoffice.gov.in and that Offline AIPR will not be accepted now onwards.

3. As such, the online AIPR for the year 2022 (as on 01.01.2023) is to be submitted by 31<sup>st</sup> January, 2023. In this regard, Special reference is invited to DoPT's O.M. No 104/33/2005-AVD.I dated 29.10.2007 and 7.9.2011 wherein it is clearly mentioned that "Vigilance clearance shall be denied to an officer for the purpose of (a) inclusion in the offer list (b) empanelment (c) any deputation for which Central Government clearance is necessary, including deputation under Rule 6(1) and 6(2)(ii) of the AIS (cadre) Rules (d) appointments to sensitive posts (e) assignments to training programmes (except mandatory training) (f) premature repatriation to the cadre, etc. if he/she fails to submit his/her AIPR by 31<sup>st</sup> January of the following year."

4. It is, therefore, requested to bring this to the notice of all the Indian Forest Service officers borne on your State/UT cadre, for compliance.

Ref: Letters of even number dated 20.12.2022 & 09.01.2023.

Please see the reference cited regarding online filing of the statement of Immovable Property Returns for the year 2022 by IFS officers. The IPR for the year 2022 is required to be submitted by 31<sup>st</sup> January 2023, online.

It is reiterated that in case the officer fails to submit his/her Annual Immovable Property Return of the previous year latest by 31<sup>st</sup> January 2023, his/her vigilance clearance will be denied in terms of DoPT OM No.104/33/2005-AVD.I dated 07.09.2011. Also, failure on the part of the members of the Service to comply with the requirements of filing of IPR as per AIS (Conduct) Rules, 1968 constitutes good and sufficient reason for institution of disciplinary proceedings against them. Further, as per Notification of DoPT dated 30.12.2021, Rule 3(1) of IFS(Pay) Rules, 2016 has been amended to make filing of IPR mandatory for being considered for appointment to the next level of pay matrix.

As per the status available in SPARROW as on 19.01.2023, only 36 IFS officers have filed their IPR online (copy enclosed).

I am directed to request you to kindly ensure that all IFS officers of Kerala Cadre who have not filed their IPR statement for the year 2022(as on 01.01.2023) online, are filed the same, latest by 31.01.2023.


