G.O.(Rt)No.72/2020/F&WLD Dated, Thiruvananthapuram, 25/03/2020

Read: G.O.(Ms) No.49/2020/GAD dated 23/03/2020.

ORDER

(1) As per item 9 of the G.O. read above, the following Departments/Offices of the State Government shall be functional with required staff, as decided by the Secretary/HoD, to control the outbreak of Novel Corona Virus (COVID-19) in the State.

- a. Secretariat/Directorates
- b. District Collectorate /Sub-Divisional Offices
- c. Police/Defence/Paramilitary Forces etc.
- d. Health
- e. Fire Services
- f. Urban Local Bodies/Panchayat Institutions/Municipal Corporations
- g. Electricity and Water Supply
- h. Civil Supplies.

(2) Government wish to clarify that the law enforcement machinery of the Forest Department, especially the forest force dealing with the protection of forest resources, human-animal conflicts, fire fighting and prevention etc., is included in Section 9 (c) of the above order.

(3) The Principal Chief Conservator of Forest & Head of Forest Force shall issue necessary orders to ensure that the minimum required staff are deployed to attend duties for the purpose of such essential activities.


