Order No. IFS I – 2753/2018 Dated: 19.01.2019

The Government of India vide notification read as first above has approved the inter cadre deputation of Sri.Anoop K R IFS (RJ:2005) and Smt. Khyati Mathur IFS (RJ:2005) from Rajasthan Cadre to Kerala Cadre. They were relieved from the parent Cadre and the Officers have reported for duty before the undersigned in the F.N of 15.01.2019. Accordingly, proposal was submitted to Government vide letter read as 6th above for posting of the above Officers. Orders from Government is awaited. Both the Officers are currently on compulsory waiting. At the same time there are several posts of Conservator of Forests lying vacant in the cadre.

In the above circumstances and in view of administrative exigencies, Smt. Khyati Mathur IFS (RJ: 2005), Conservator of Forests is directed to hold the charge of Conservator of Forests (HRD) Thiruvananthapuram and Sri.Anoop K R IFS (RJ:2005), Conservator of Forests is directed to hold the charge of Conservator of Forests (WL) in charge of Agasthyavanam Biological Park which is currently held as full additional charge by Shri.Pramod P P IFS, Deputy Conservator of Forests, till orders are received from the Government.

This order is issued subject to ratification by the Government.
