Remya S, vide letter read as 1st, 2nd, 3rd & 4th above respectively for appointment as Range Forest Officers in the Kerala Forest Department under Direct Recruitment earmarked for those who possess a Degree in Forestry, Science or Engineering. Government vide letter read as 5th had issued direction to appoint Sri. A. Vijin Dev for the post of Range Forest officer under Direct Recruitment quota earmarked for those who possess a degree in Science or Engineering.

The above said candidates were deputed for the Eighteen month Forest Range Officer Training Certificate Course at Tamil Nadu Forest Academy, R.S.Puram, Coimbatore (TN) as per the order read as 6th above. The above 5 candidates joined the Forest Range Officers course 2017-18 that commenced from 20th February 2017. In the letter read as 7th above, the Director, Tamil Nadu Forest Academy, Coimbatore intimated that all the trainees have successfully completed the Eighteen month Forest Range Officer training Certificate Course and have been relieved from the Academy on the AN of 18th August 2018.

As per Rule 9 (f) of Kerala Forest Service Special Rules, 2010 the Range Forest Officers appointed by direct recruitment under item (i) (a) under

category 3 of Rule 3, on satisfactory completion of training in the Forest Rangers' College shall undergo practical training in the Forest Department for a period of one year. During the period of Rangers Training in the Forest College and the period of practical training in the Department, the candidates shall be paid basic pay and other admissible allowances. The period spent for training in the Forest College and practical training in the Department shall be counted for pension and leave. Accordingly the following candidates are ordered to undergo practical training as per the programme appended to this order as Annexure - I

The training will be deemed to have commenced from the Fore noon of the date of reporting for practical training in the assigned Range headquarters. The Range Forest Officer trainees are ordered to report in respective Ranges to which they are attached for training immediately after availing actual journey time. During the period of their training, the Range Forest Officer trainees will be under the control and supervision of the Divisional Forest Officers concerned. During the practical training, the Range Forest Officer trainees will be paid basic pay and other admissible allowances due, from the office of the Divisional Forest officer to which they are attached for practical training.

The Divisional Forest officers concerned shall take appropriate decision for conducting the training as scheduled. After completion of practical training the trainees shall be relieved with direction to report before the undersigned.

After each lap of training the Range Forest Officer trainees will prepare a detailed report covering the various aspects of their training and submit to the Divisional Forest Officer who in turn will forward the same to the Chief Conservator of Forests /Conservator of Forests (territorial) with remarks. The Chief Conservator of Forests will furnish half yearly and annual assessment report of wok and conduct of the Range Forest Officer trainees to the Additional Principal Chief Conservator of Forests (Administration).
