The Wildlife Institute of India (WII), an autonomous institution of the Ministry of Environment, Forest and Climate Change, Government of India invites applications from the eligible Range Forest Officers under State Forest Department for filling up one post of Field Technical Officer (FTO) on deputation in Level 7 of Pay Matrix with Basic Pay of Rs. 44900/- plus usual allowances as admissible under Central Government Rules.

**Eligibility:** Range Forest Officers with not less than five years of service in the field of State Forest Departments.

**Desirable:** Experience of working in National Park/Wildlife Sanctuary/Tiger Reserve.

**General Instructions:**

- (1) **Pay:** The officer on appointment on deputation to the Institute will get basic pay plus deputation allowance as per provisions under DoPT OM No.6/8/2009-Estt (Pay-II) dated 17.06.2010 as amended from time to time OR the officer will be allowed to draw his parent cadre pay.
- (2) **Deputation Period:** The deputation period would initially be for a period of three years from the date of assumption of charge to the post and may be extended for another period of two years.
- (3) **Age:** Below 50 years as on 30.09.2017.

- (4) **Last date of Receipt of Applications:** The last date of receipt of application is 30<sup>th</sup> September, 2017.
  - (5) Applications with complete bio-data of the candidate (as per format attached) should be submitted to the Administrative Officer, Wildlife Institute of India, Post Box No.18, Chandrabani, Dehradun on or before 30.09.2017.
  - (6) The application should be routed through proper channel. Vigilance Clearance Certificate along with Annual Confidential Reports for the last five years of the officer should also be sent along with application. However, an advance copy can be submitted by the individual officer.
  - (7) Consent of the State Forest Department should be given indicating that on selection for deputation appointment, the officer will be relieved to join the post of Field Technical Officer on deputation at WII, Dehradun.
  - (8) The WII reserves the right not to fill up the vacancy advertised if the circumstances so warrant.
