Government vide GO read as 1st above have granted permission to appoint 21 Deputy Range Forest Officers as Range Forest Officers temporarily under Rule9(a)(i) Part II Kerala State & Subordinate Service Rule. On the basis of the condition prescribed by Government 13 Deputy Range Forest Officers were promoted to the cadre of Range Forest Officers temporarily as per Rule 9(a) (i) of Kerala State and Subordinate Service Rules as per order read as 2nd above.

2. Sri. I.P.Sanil, Range Forest Officer has been placed under suspension as per order read as 3rd above. As such one vacancy of Range Forest Officer arose in the Department. This vacancy has to be filled up by temporary appointment of senior most eligible Deputy Range Forest Officer from the list approved by Government vide order read as 1st above .

3. Sri.N.Ganesan, Deputy Range Forest Officer having seniority No.63 in the provisional seniority list of Deputy Range Forest Officers as on 01.03.2011 is the next Deputy Range Forest Officer who qualifies the conditions stipulated by Government in the order read as 1st above. His name is also included as Serial

No.14 in the list approved by Government in the GO read 1st above and as such he is eligible for temporary appointment as Range Forest officer.

4. Under the above circumstances, Sri.N.Ganesan, Deputy Range Forest Officer is appointed temporarily as Range Forest Officer in the scale of pay of Rs. 20,740-36140 as per Rule 9(a) (i) of Kerala State and Subordinate Service Rules.

5. The temporary appointment of Sri.N.Ganesanas as Range Forest Officer is subject to the following conditions

1. The appointment as Range Forest Officer is over and above the quota fixed for promotion of Deputy Range Forest Officer and therefore this appointment is purely on temporary basis
2. He will be reverted without any notice when eligible hands join duty, if he cannot be accommodated in the respective eligible quota
3. This appointment will be regularized as and when vacancies earmarked for promotion as Range Forest Officer will occur in the respective quota after following the procedures prescribed in the Rules.
