ORDER NO. D1-27438/2010 DATED 20.11.2013

- 1. Government vide GO read as 1st above have granted permission to appoint 21 Deputy Range Forest Officers as Range Forest Officers temporarily under Rule9 (a) (i) Part II Kerala State & Subordinate Service Rules. Government vide GO read as 2nd above has granted permission to include S/Shri.M.Padmanabhan, Ramachandran Muttil and C.Shereef, Deputy Range Forest Officers as SI.No. 9A, SI.No.11A and SI.No.15A respectively in the approved list of Deputy Range Forest Officers for temporary appointment as Range Forest Officers issued as per G.O read as 1st above. On the basis of the conditions prescribed by Government, Deputy Range Forest Officers up to SI.No.15 as per the list approved by Government vide G.O read as 1st and 2nd above were appointed to the cadre of Range Forest Officers temporarily as per Rule 9 (a) (i) of Kerala State and Subordinate Service Rules, as per order read as 3rd above.
- 2. Shri.Joshi Sebastian and Shri.K.K.Sabu, Range Forest Officers have been placed under suspension as per order read as 4th and 5th above respectively. As such there are two vacancies of Range Forest Officers in the Department. These vacancies have to be filled up by temporary appointment of senior most eligible Deputy Range Forest Officers from the list approved by Government vide order read as 1st and 2nd above.
- 3. Shri.C.Shareef and Shri.P.Satheesan, Deputy Range Forest Officers having seniority No.67 and 68 respectively in the provisional seniority list of Deputy Range Forest Officers as on 01.03.2011 are the next senior most Deputy Range Forest Officers who qualifies the conditions stipulated by Government in the order read as 1st above. Their

names are included as Serial No.15 (A) and 16 in the list approved by Government in the GO read as 1st and 2nd above. They are eligible for temporary appointment as Range Forest officer.

- 4. Under the above circumstances, Shri.C.Shareef and Shri.P.Satheesan, Deputy Range Forest Officers are appointed temporarily as Range Forest Officers in the scale of pay of Rs. 20,740-36140 as per Rule 9 (a) (i) of Kerala State and Subordinate Service Rules.
- 5. The temporary appointment of Shri.C.Shareef and Shri.P.Satheesan as Range Forest Officers is subject to the following conditions
 - i. The appointment as Range Forest Officer is over and above the quota fixed for promotion of Deputy Range Forest Officer and therefore this appointment is purely on temporary basis
 - ii. He will be reverted without any notice when eligible hands join duty, if they cannot be accommodated in the respective eligible quota
 - iii. This appointment will be regularized as and when vacancies earmarked for promotion as Range Forest Officer will occur in the respective quota after following the procedures prescribed in the Rules.
