As per the Government Order read as 1st above, 25% of the posts of Senior Superintendents are to be placed in the Higher Grade in the scale of pay of Rs.20740 - 36140. There are 34 posts of Senior Superintendents in the department. As such eight posts of Senior Superintendents of the department have been upgraded as Senior Superintendent (Higher Grade) and the following eight Senior Superintendents who were eligible, had been sanctioned ratio based higher grade in the post of Senior Superintendent vide the orders read as 5th above.

The above said officers have been promoted as Administrative Assistants. As such, there are eight vacant posts of Senior Superintendents (HG) in the department.

As per the seniority list of Senior Superintendents as on 01.11.2011, Shri.Muraleedharan.P (Sl.No.11) is the next senior most. Smt.Jessy.P.O (Sl.No.13) has relinquished promotion for one year with effect from 07.03.2012. Shri.Suresh.M (Sl.No.16) retired on superannuation on 31.05.2012 before being eligible for ratio promotion. Shri.Sugathan.K.M (Sl.No.12) and Shri.Sasidharan Pillai.K.P (Sl.No.17) also retired from service on superannuation on 31.10.2012 and 30.11.2012 respectively.

The seniority of Smt.R.Remadevi and Shri.K.J.Joseph in the cadre of U.D.Clerk has been revised as on 01.01.2001 and thereby their positions in the seniority list of Junior Superintendents have also been assigned.
