Order No. D1-27438/2010 Dated 31.10.2013

Government vide GO read as 1st above have granted permission to appoint 21 Deputy Range Forest Officers as Range Forest Officers temporarily under Rule9(a)(i) Part II Kerala State & Subordinate Service Rule. Government vide GO read as 3rd above has granted permission to include S/Shri M.Padmanabhan, Ramachandran Muttill and C.Shereef Deputy Range Forest Officers as Sl.No 9A,Sl.No11A and Sl.No15A respectively in the approved list of Deputy Range Forest Officers for temporary appointment as Range Forest Officers issued as per G.O read as 1st above.. On the basis of the conditions prescribed by Government, Deputy Range Forest Officers up to Sl.No.14 as per the list approved by Government vide G.O read as 1st and 3rd above were promoted to the cadre of Range Forest Officers temporarily as per Rule 9(a) (i) of Kerala State and Subordinate Service Rules as per order read as 2nd above.

3. S/s P.K.Pradeep and T.R.Ashok kumar Range Forest Officers are retiring from service on 31.10.2013.Hence two post of Range Forest Officers will be vacant with effect from 01.11.2013 in the Department. Sri,B.Renjith,Range Forest Officer was deputed for training in Central Detective Agency, Hyderabad is expected to rejoin in the department after completing the training on 03.11.2013. Hence one post has to be kept vacant to accommodate him. The other vacancy has to be filled up by giving temporary appointment to the next eligible Deputy Range Forest officer included in the list approved by the government vide G.O read as 1st above.

4. Sri.K.P.S.Boby Kumar, Deputy Range Forest Officer having seniority No.64 in the provisional seniority list of Deputy Range Forest Officers as on 01.03.2011 is


the next senior most Deputy Range Forest Officer who qualifies the conditions stipulated by Government in the order read as 1st above. His name is also included as Serial No.15 in the list approved by Government in the GO read as 1st above. He is eligible for temporary appointment as Range Forest officer.

5. Under the above circumstances, Deputy Range Forest Officer Sri. K.P.S. Bobby Kumar is appointed temporarily as Range Forest Officer in the scale of pay of Rs. 20,740-36140 as per Rule 9(a) (i) of Kerala State and Subordinate Service Rules.

6. The temporary appointment of Sri. K.P.S. Bobby Kumar as Range Forest Officer is subject to the following conditions

1. The appointment as Range Forest Officer is over and above the quota fixed for promotion of Deputy Range Forest Officer and therefore this appointment is purely on temporary basis
2. He will be reverted without any notice when eligible hands join duty, if they cannot be accommodated in the respective eligible quota
3. This appointment will be regularized as and when vacancies earmarked for promotion as Range Forest Officer will occur in the respective quota after following the procedures prescribed in the Rules.
