Vide reference cited first above, Shri.G.Krishnadas, Forester was promoted and posted as Deputy Ranger, Kanthalloor Forest Station of Marayoor Forest Division. Now Shri.G. Krishnadas vide his representation dated: 7/7/2011 has requested to post him in Ernakulam District or in a near by station so as to take care of his differentially abled girl child. It is found that there is merit in his request and deserves a compassionate consideration. Kanthalloor section of Marayoor Forest Division is a sensitive station with respect to the protection of the Sandalwood. Therefore an efficient officer has to be posted there.

So also Sri.K.Abdul Razak, Deputy Ranger has to be posted in a place other than a forest station on reinstatement after suspension as per order No.B7-4324/01 dt. 12/08/2011 of the Chief Conservator of Forests (TM).
