Sub:- Forest Department – Establishment - Reassigning seniority of Range Forest Officer of Sri.M.A.Anaz in the cadre of Range Forest Officer –Confirming the Temporary decision-- reg.

Shri.M.A.Anaz was advised by the Kerala Public Service Commission for appointment as Range Forest Officer under Direct Recruitment (DR) quota vide letter cited as 1st above. He was positioned as Sl.No.5 after Shri.Shanavas.A (Sl.No.4) and before Shri.Ani.J.R (Sl.No.6) in the advice letter under reference (1). In the final seniority list of Range Forest Officers as on 01.01.2011 published as per Order read as 2nd above, his position was temporarily fixed as Sl.No.112 on the condition that the actual position of seniority in the cadre of Range Forest Officer can be assigned on regularization of appointment as Range Forest Officer for which separate order will be issued in due course. The appointment of Sri.M.A.Anaz in the cadre Range Forest Officer has been regularized with effect from 11.07.2001 vide order read as 3rd above and his probation in the cadre of Range Forest Officer has been declared as satisfactorily completed with effect from the A.N. of 29.10.2008 vide order read as 4th above.

Sri.M.A.Anaz, Range Forest Officer has submitted representation dated 18.03.2013 for assigning his due seniority. As per Rule 9 (b) of Kerala Forest Subordinate Services Special Rules, 1962, the seniority of candidates recruited direct shall be determined according to the order in which their names are arranged in the advice list of the Public Service Commission. As per Rule 27 of the Kerala State and Subordinate Service Rules,1958, the seniority of a person in a service, class, category or grade shall unless he has been

reduced to a lower rank as punishment, be determined by the date of the order of his first appointment to such service, class, category or grade.

As per the the Notice read as 5th above it was provisionally decided to assign seniority of Sri. M.A.Anaz in the cadre of Range Forest Officer as SerialNo.12(A) between Sri.Ashokan.A.Machingal (Sl.No.12) and Sri.J.R.Ani (Sl. No.13) in the final seniority list of Range Forest Officer as on 01.01.2011 published as per Order read as 2nd above. The Range Forest Officers concerned were requested to prefer appeals if any, against the provisional decision, through their head of offices within seven days from the date of publication of the notice. No appeals have been received till date.

In the above circumstances, I, V. Gopinathan, Principal Chief Conservator of Forests (Wildlife) & Chief Wildlife Warden, Kerala do hereby order that the provisional decision to assign seniority of Sri. M.A.Anaz in the cadre of Range Forest Officer as Serial No.12(A) between Sri.Ashokan.A.Machingal (Sl.No.12) and Sri.J.R.Ani (Sl. No.13) in the final seniority list of Range Forest Officer as on 01.01.2011 published vide order read as 2nd above is confirmed
