1. **Scale of Pay: Level -16 of 7th CPC (Annual Increment @ 3%)**
2. **Eligibility:** Officers/Academicians of the Governments/Universities/Other Recognized Institute/Organizations serving on regular basis in the Pay Level-15 of 7th CPC (Annual increment @3%) or equivalent grades or above.

OR

Person with 05 years service in the Pay Level-14 of 7th CPC under Central/State Government/Public Sector Undertaking/Autonomous Bodies/Universities or equivalent grades or above.

3. **Essential Qualifications: For IFS Officers:**
 - (i) Master's Degree or equivalent with outstanding academic track record.
 - (ii) 15 years of administrative/management/research/teaching experience including 10 years experience in forestry and allied sectors.

Desirable : Ph.D. in a relevant discipline.

For Academicians :

- (i) Master's Degree or equivalent with outstanding academic track record
- (ii) In case of academicians applicants should have been a Professor at a reputed institution for at least 7 years and have at least 5 years of experience in administrative areas.

Desirable : Ph.D. in a relevant discipline.

The ideal candidate should have a mix of administrative and academic leadership in institution-building, promoting education and research, and would have displayed interest in the problem of environment/forestry/wildlife issues.

4. Age: Should not exceed 57 years as on the date of arising of vacancy. In exceptional cases relaxation may be given.
5. Terms and Conditions: Appointment shall be for a period not exceeding 5 years or date of superannuation whichever is earlier.

Note:

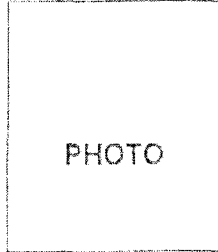
- (i) The applications of those in the government service must be sent through Proper Channel along with the records of Confidential Reports and Vigilance Clearance.
