Regulations.

No. 332 .- His Excellency the Governor in Council is pleased to declare, under the provisions of section 16 of the Madras Forest Act (V of 1882), that, from the 1st September 1900, the area, the boundaries of which are set forth in the schedule appended to this notification, shall be constituted a " reserved forest."

North.—Starting from the Grand Trigonometrical Survey station on the Anginda Peak on the boundary between the Nilgiri and Malabar districts forming the trijunction of the Walayanad and Ernad taluks of the latter and the Kundah division of the former, the reserve boundary passes custward along the tops of the hills between Malabar and Nilgiris for nearly four miles to the point at which the Bhavani river crosses the Nilgiri boundary.

East.—Then turning southward it follows the right bank of the above river southward to a point thoroon opposite the junction therewith of the Yedanali stream draining Tayikkarai Malai.

Santh.—Thence leaving the river, it runs up west, slightly south, to the top of Konnala Malai and thence in a generally westerly direction along the Panakkandi Nedi or water: shed to its westernmost point and thence north-westward to the north-ensternmost peak of the Adu Mudi ridge; thence south-west and saddles forming it, to the Madras triangular station on the top of Adu "udi: thence south-east down Adu Mudi slope to the elophant pit saddle and on in the same direction to the top of Koingai Malai: thene south to the top of Kothala Kunnu, south-west three furlongs to the northern elbow of the Karuvarai Todu about one mile west of Karuvarai village and the same distance east slightly north of Kuruvarai Mudi: thence due westward to the top of the castern end of the Arayamparai Malai ridge; thence along the ridge westward to the top of the Arayamparai peak on the Ernad and Walayanad taluk boundary.

West.—Thence northwards along the boundary between the Ernad and Walayanad taluks to the starting point.

BLOCK No. II.

North .- Starting from the top of Mukkali Mudi, the boundary passes north-east to the top of Villakkota Malai

East.—Thence southwards to the slope of the Chanda Malai peaks in succession and from the last mentioned peak south, slightly east, down the slope of the latter to a point on an imaginary line drawn from Kevaralai village to Analkatto village a quarter mile south-cast of the former village.

South.—Thence westward to the summit of Nayivara Malai.

South.—Thence westward to the summit of Nayivara Malai.
West.—Thence northwards to the top of Uppukayi Malai and then due west to the starting point.

BLOCK No. III.

North.—Starting from a point on the left bank of the Bhavani river slightly over one-fourth of a mile north of the junction of the Muriyala Nadi (stream) with the Bhavani river, the boundary runs up the shoulder of the Pisathi or Kuppada Malai to its summit.

Ada Mudi peak; thence south-westward to the top of Kandra Mudi and thence south-castwards to the top of Kelaki (east)
Ada Mudi peak; thence south-westward to the top of Tayikkarai Malai.

South.—Then down the slope of Tayikkarai Malai west-south-west to the left bank of the Bhavani river, a
quarter mile north of the junction therewith of the Yodanali Todu.

West.—Thence northward along the left bank of the river back to the starting point.

BLOCK No. IV.

North.—Starting from the left bank of the Bhavani river at the Mudamanur ferry, a quarter mile south of Chindakki, the boundary passes east-north-east to the top of Ajji Mudi and thence north-east to the top of Mallesuvaran Mudi also called Mannarkad rock.

East.—Thence southward down the slope of the last mentioned hill to the source of the Yellakorai Nadi (stream and thence the right bank of that stream to a point thereon half a mile north of its junction with the Bhavani

river.

South.—Thence west-south-west to the top of Thaimbara Malai or Tenvavai Malai and on slightly more west down the western slope of that hill to the Bhavani river at the junction therewith of the Thaimbara Nadi

West.—Thence northward along the left bank of the Bhavani river to the starting point at the Mudamanur ferry.

No. 333.—Whereas the proprietor of the Pondavakkam shrotriem in the Ponneri taluk, Chingle-put district, has submitted an application for the survey of his estate and has consented in writing to defray the whole cost of such survey, His Excellency the Governor in Council, in exercise of the power vested in him by section 17 of the Madras Survey and Boundaries Act (IV of 1897), hereby directs that the survey of the said shrotriem be undertaken and conducted by the Madras Survey Department in accordance with the provisions of the said Act.

No. 334.—In rule 13 (iii) of the rules under section 26° of the Forest Act, published at pages 981-983, Part I of the Fort St. George Gazette, dated 21st August 1894, omit the words "as well as to the contractors employed by them" and insert in their place "and with the previous sanction of Government in each case to other public bodies."
