Situation:—This Reserve is situated about a mile north of Ezhalloor village site and comprises survey number 1467/1 and a portion of survey number 14:3/1 of Kumaramangalam village and survey number 758/1 of Karimannoor village, Thodupuzha taluk. This 6 feet bridle path starting from cairn No. 156 on the southern boundary, rons in a north easterly direction for about 15 chains to meet the northern boundary, and leaves the reserve at about 2 chains south-east of cairn No. 3

Remarks:— There is no other right either public or private within the Reserve than the one specified above.

NOTIFICATION.

Under sanction of His Highness the Maha Raja Rule 40 of the Education Code is amended as follows:—

Rule 40. Every pupil, unless he can show that he has had smallpox, shall be vaccinated and if more than 5 years have elapsed since he was last vaccinated, he shall be revaccinated.

When any pupil not protected from smallpox as above is admitted to a school master shall, within 24 hours, inform the Sanitary Officer of the District, within school is situated, of the fact in writing and request him to make arrangements nation of the pupil. But, if the school is situated within an area over which placed, the Headmaster shall inform the Vaccinator of the fact in writing visit the school for the purpose of vaccinating the pupil. If, in either dupil refuses to submit to Vaccination or revaccination, or if the parent of from being vaccinated or revaccinated, the pupil shall be discharged transfer certificate shall be granted in such cases without the sanction of
