The Diwan is pleased to declare under the provisions of section XII of the Cochin Forest Regulation III of 1080, the areas, the boundaries of which are described in the schedule below, "Reserved Forests" under the said regulation, with effect from 15th Karkidagom, 1084, the Forest Settlement Officer appointed under clause C, section VIII of the aforesaid Regulation, having enquired into and disposed of all the claims that were brought forward.

Taluk - Trichur

No and Name of Block - 50, Mandan Chira.

Boundaries

The demarcated, surveyed and mapped boundaries of survey number 1077 of village number 72, Panancheri, with the following exclusions:-

Survey number A to the north of survey number 803 and to the east of Survey numbers 802, 801 and to the south of survey number 800 measuring 67 cents

Sy. No. B to the west of Sy.No. 804 to the south of Sy Nos. 806, 807, 825 and 826 and to the east of survey No:825 and 827 and to the north of survey No. 829 measuring 5 acres 48 cents.

Survey number C to the east of survey number 830 measuring 34 cents.

Survey number D to the south of survey numbers 830, 831 and 832 measuring 61 cents.

Survey number E to the south of survey numbers 832, 837 and 838 measuring 2 acres 58 cents.

Survey number F to the west of survey numbers 1082, 1086, 1087, 1092, 1090, 1091, 1098, 1100 and 1101 and to the south of survey numbers 1102, 1103 and 1106 measuring 13 acres 23 cents.

Survey number G to the North of survey number 1110 measuring 40 cents.

Survey number H to the North of survey number 1111 and west of Survey no 1113 measuring 31 cents.

Survey number I to the west of survey numbers 1082, 1080 and 1078 and to the north of Survey Numbers 1047 and 1076 measuring 21 acres 26 cents.

Survey number J to the west of survey number 782 and south of survey No. 783 measuring 44 cents.

The following rights and privileges are admitted in the Reserve:-

1. A cart track from survey number 1077/B and passing through the Reserve and getting out to survey number 1077/F.

2. Another cart track from survey number 1045 and passing through the Reserve by the side of survey number 1047 and getting out to survey number 1077/I

These will be preserved.

NB. The areas of the blocks, exclusions, etc. specified above are subject to revision on re-measurement on the ground.
