## NEMMINAD RESERVED FOREST NOTIFICATION

Fort St. George, June 12, 1939.

No 480.—In exercise of the powers conferred by sub section (4) of section 17 A of the Madras Forest Act, 1882 (Madras Act V of 1882), the Government of Madras are hereby pleased to redefine the limits of Nemminad Reserved Forest, Malabar District, so as to remove the defects in the description of the limits of the said forest in Revenue Department Notification No.223, dated 4th May 1906, published at page 495 of Part I of the Fort St. George Gazette, dated the 4th May 1906, by making the following correction to the limits of the said forest:—

## Correction

For the schedule to the said Notification the following schedule shall be substituted namely:—

## **Schedule**

Malabar—District, Wynaad—Taluk, Nemmini—Amsom, Nemmeni—Desom (Name of Forest:—Nemminad Reserved Forest. Area in acres—922.94)

## **Boundaries**

North:—Starting from the north east corner of survey No. 1060 of Nemmeni desom the trijunction of S.Nos. 1060, 927 (Sultans Battery-Nellakotta road) and 1490-1 (Nemminad Reserved Forest) the west margin of the Sultans Battery-Nellakotta road (Survey No.927, of Nemmeni and 734 to 736 of Nulpuzha desom) to the northernmost corner of survey No. 1493, thence the west side of survey No.1493, south sides of survey No.1494, west sides of survey Nos. 1495, and 1497 north sides of survey Nos. 1498 and 1499, north, west and south sides of survey No. 1500 and the south sides of survey Nos. 1501, 1502 and 1497 again to the west margin of the said road.

East.—Thence the west margin of the said road [Survey Nos. 740 to 742 of Nulpuzha desom 1516 to 1519 of Nemeni and 743 (part) 744 and 745 of Nulpuzha desom] to the Nilgiris district boundary.

South.—Thence westwards along the said district boundary to the easternmost corner of survey No. 1526-2, thence the east sides of survey No. 1526-2, north and west sides of survey No.1526-1, north and west sides of survey No. 1525, and the north sides of survey Nos.1524 and 1523 to the said district boundary at the north west corner of the last mentioned field, thence northwards along the said district boundary to the south-west corner of survey No.1521, thence its south sides and the west (part) south-east and north sides of survey No.1522, east and north sides of survey No.1520 and the north side of survey No.1521 again to the said district boundary thence the said district boundary to the south-east corner of survey No.1508, thence the east side of survey Nos.1508 and 1510, east and north sides of survey No.1514, north sides of 1510 again and 1513, north and west sides of survey No.1503, west sides of survey Nos.1504, 1505, 1506 and 1490-3 to the Nilgiris district boundary; and thence the said district boundary to the easternmost corner of survey No.1484.

West.—Thence the northern (part) sides of survey No. 1484 and the east sides of survey Nos. 1486, 939 and 1060 to the starting point.

The Nemminad reserve comprises the whole of survey Nos.1490-1, 1491, 1492, 1527-1 and 1509 of Nemmeni amsom and desom.

Remarks.—(i) The following temple sites are admitted as enclosure within the reserve:

Survey Nos. 1490-2 of 0.28 acre and 1527-2 of 0.08 acre in extent, (ii) The following rights of way are admitted within the reserve.

- (i) (A) Cart track for which there is no local name is open to people, cattle and carts. It is 10 yards wide and 1600 yards long. It enters the reserve on the Sultans Battery-Nellakotta road at a point 704 yards north from the southeast corner of the reserve, and runs generally west by south and quits the reserve at a point 55 yards north of the south-east corner of survey No.1522 of Nemmeni desom.
- (ii) A cart track leading from the Sultans Battery-Nellakotta road to the Nilgiris district boundary and for which there is no local name is open to people, cattle and carts. It is 10 yards wide and 1275 yards long. It enters the reserve on its western boundary at the survey stone next north of the south-eastern corner stone of survey No. 1060 and runs generally south and leaves the reserve on its southern boundary at a point 275 yards east from the easternmost point of survey No. 1484.
- (iii) A path for which there is no local name, is open, to people, and cattle only. It is 10 yards wide and 5 furlongs long. It enters the reserve on its western boundary at the point where path No. II supra enters the reserve, and runs generally in a south-easterly direction and quits the reserve on its southern boundary at a point 2 chains west from the northernmost point of survey No.1513.
- (iv) A path, for which there is no local name, is open to people only. It is 3 feet wide and 100 yards long. It branches off from the cart track No.I supra at a point 15 chains (measured along right of way No.I) west by south from the Sultans Batter)-Nellakotta road and runs generally northwards to meet the southern boundary of S.No.1527-2 (an enclosure within the reserve) at a point 11 yards from its southeastem corner.
- (v) A path for which there is no local name, an open to people only. It is 3 feet wide and 40 yards long. It enters the reserve on its western boundary at a point 3 ½ chains north of the seventh survey stone on the east side of survey No.1060 (counted southwards from the southernmost corner of S.No.927) and runs eastwards to meet the western boundary of S.No.1490-2 (an enclosure within the reserve) at a point 11 yards north of its south-western corner.
