SANCTUARY NOTIFICATION

GOVERNMENT OF KERALA

G.O. MS. No.871

Dated, Trivandrum, 6th August 1958

In exercise of the powers conferred by section 27, 29 and 93 (2) of the **Travancore – Cochin Forest Act, 1951 (Act III of 1952)**, Government of Kerala hereby **make** the following rules, namely: -

RULES

10.1.1 Rules

1. From the date of publication of these rules in the Government gazette, the waterspread and catchment areas of Vazhani cum Perechi Dams and Neyyar Dam falling within the boundaries specified in the schedule appended to these rules shall be treated as Wildlife **Sanctuaries**:
2. The areas referred to rule I shall be permanently closed against all shooting, hunting, felling and cutting down timber, collection of forest produce, **grazing** of cattle and **all trespasses** except under and with the **specified** orders of the Government.

Name of the area	:	Neyyar Wildlife Sanctuary
District	:	Trivandrum
Taluk	:	Neyyattinkara and Nedumangad
Extent	:	About fifty (50) sq.miles.

Boundaries

North: Starting from a point on the watershed line between Neyyar and Karamana Rivers about one and half miles north-west of Neyyar Dam site, the boundary runs more or less **north-east** along **the** watershed line upto the State **boundary** at Adurai Malai (5222 ft.) via. **Ottuparai**, Pottimalai and **Nachiyadikunnu**.

East: Thence more or less **south-east** along the State boundary upto a point on the State boundary about **at** mile north-west of **Kurichimalai**.

South & West: Thence more or less north-west along the western catchment boundary of Neyyar Reservoir passing Poomalai and **Kurunjankani (1190 ft.)** and Neyyar dam till it meets the starting points.

In exercise of the powers conferred by Section 30 and 76 (g) of the Kerala Forest Act, 1961 (4 of 1962), the Government of Kerala hereby make the following amendment to the rules published under Notification No. G.O. (MS) No.871 dated the 6th August 1958 at page 3600 Part 1 of the Travancore-Cochin Gazette, dated the 19th August 1958 namely: -

10.1.4.1 AMENDMENT

In the said notification, in part (ii) relating to the boundaries of the water spread and catchment areas of Neyyar Dam treated as Wildlife Sanctuary for the entries under the heading "Boundaries", the following entries shall be substituted, namely:

10.1.5 BOUNDARIES

North: Starting from a point on the watershed line between Neyyar and Karamana rivers about 2.41 km. North-west of Neyyar Dam Site, the boundary runs more or less north-east along **that** watershed line up to a point on the boundary of Kottoor extension reserve forests about 2.41 km, south-east of Kottoor, i.e., cairn No.20 of the Kottoor extension reserve forest, the boundary goes north for about 20 m to cairn A, thence almost east for about 62.30 m to cairn '**B**', thence more or less north for about 324.6 m passing cairns **C,D,E,F,G** and to cairn **H**, then slightly east for about 180.5m passing cairns I,J,K &L thence north east for about 76.78 m passing cairns M to N, thence north for about 33.3 m to cairn No.'**O**', thence towards east for about 37.3 m to Cairn '**P**' thence to north-west for about 349.16m to cairn S passing cairn Q&R thence more or less north-east along the watershed

line between Neyyar and Karamana rivers up to the state Boundary at Adurai Malai **via**, Chottuparai, Pottimalai and Nachiyadikunnu.

East: Thence more or less southwards along the state boundary upto a point on the state boundary about a mile northwest of **Kurichimala**.

South:Thence more or less north-west along the western catchment boundary of Neyyar Reservoir passing Poomalai and Kurunjakani (1190 ft.) and Neyyar Dam till it meets the starting points.
