NOTIFICATION

Part I

The Diwan is pleased to declare under the provisions of section 12 of the Cochin Forest Regulation III of 1080 the areas to the boundaries of which are described in the schedule below, "Reserved Forest" under the said Regulation with effect from 8th October 1911(22nd Kanni 1087), the Forest settlement Officer appointed under clause C section 8 of the aforesaid Regulation, having enquired into the disposed of all the claims that were brought forward.
