Agr.F(b)4 63626/58 Agri (F(B) 4) Dt. Trivandrum 6th Oct.1959

In pursuance of clause (a) and (b) section 4 of the Madras Forest Act,1882 (Act V of 1882), the Government of Kerala hereby notify that it is proposed to constitute as a "Reserve Forest" under the said Act, the lands within the boundaries specified in the schedule below.

BOUNDARIES

North: Starting from the junction of the Moothaveedu puzha and the Valia puzha, the boundary proceeds generally eastwards along the Moothaveedu puzha (which is also the Southern boundary of the Moothaveedu Cherikkallu) to the point where the puzha cuts the common boundary between the Kurumbranadu and Wynad Taluks.

East: Thence along the said common taluk boundary, generally southwards, to the point where the Taluk boundary is cut by the Oni alias Peruvanna puzha.

South: Thence generally westwards along the Onipuzha to its junction with Valia puzha.

West: Thence generally north-westwards along the Valia puzha to reach the junction of the Valia puzha and the Moothaveedu puzha, the starting point.

II In exercise of the the powers conferred by clause (c) of Section 4 of the Madras Forest Act,1882 (Act V of 1882), the Government of Kerala hereby appoint the Revenue Divisional Officer, Kozhikode Ex-officio to be the Forest settlement officer in regard the lands within the boundaries specified in the schedule to notification no 1 to enquire into and determine the existence, nature and extent of any rights, claimed by or alleged to exist in favour of any person, in or over any land comprised within such boundaries or to any forest produce of such land and to deal with the same as provided in Chapter II of the said Act.

III In exercise of the powers conferred by the last paragraph of section 4 of the Madras Forest Act,1882 (Act V of 1882), the Government of Kerala hereby appoint the District Forest Officer of Kozhikode Division Ex-officio to attend on behalf of Government at the enquiry under chapter II of the said Act held by the Forest Settlement Officer, appointed by notification No.II.

IV In exercise of the In exercise of the powers conferred by the section 14 of the Madras Forest Act,1882 (Act V of 1882), the Government of Kerala hereby appoint the Collector of Kozhikode, Ex-officio to hear appeals from orders passed under Section 11, 12 and 13 of the said Act, by the settlement Officer, appointed by notification no II.
