Quilon.	<p><i>Situation.</i> The Reserve is situated about three miles north east of Ranni and two miles north of Perunad Village sites and west of the Pombay river and comprises almost the whole of Survey Number 781/1 and a portion of Survey Number 779/1 of Ranni Village, Chengannur taluk.</p> <p><i>Boundaries.</i></p> <p><i>North.</i> Starting from cairn No. 1 situated at the south-eastern corner of Survey Number 10/1 of Ranni Village, Chengannur taluk the boundary runs eastward along the south sides of survey Nos. 8/1, 7/1 and 5/1 for about 107 chains passing cairn Nos. 2 to 21 to cairn No. 22, thence leaving the Revenue Survey line the boundary runs east south east for about 3 chains to cairn No. 23, thence south east for about 15½ chains passing cairn Nos. 24 & 25 to cairn No. 26, thence south for about 8½ chains passing cairn No. 27 to cairn No. 28, thence more or less south east for about 25¼ chains passing cairn Nos. 29 to 32 to cairn No. 33, thence more or less eastward for about 94 chains passing cairn Nos. 34 to 46 to cairn No. 47, situated at the tri-junction of Survey Numbers 779/1, 780/1 and 780/2 (Cheria Chembenmudi Cheral).</p>	sq. miles & 379.24 acres.	

East. Thence the line runs more or less south-west along the north side of Survey No. 780/2 passing cairn Nos. 48 to 54 to cairn No. 55, at the tri-junction Survey Numbers 788/11 (Valia Chembenmudi Cheral), 779/1 and 780/2, thence in the same direction along the northern side of S. No. 781/11 passing cairn Nos. 56 to 69 to cairn No. 70 at the tri-junction of Survey Numbers 779/1, 781/1, 781/11, thence skirting the west and south sides of the last mentioned Survey No. (781/11) passing cairn Nos. 70A and 71 to 116 to cairn No. 117 at the tri-junction of Survey numbers 781/11, 781/1, and 780/1, thence south south east along the west side of S. No. 780/1, passing cairn Nos. 118 to 133 to cairn No. 134 on the right bank of the Pombay river.

South. Thence the line runs south west along the said bank of the river for about 51 chains to cairn No. 135 at the Kodumpuzha Aruvi on the Pombay river, thence westward for about 16½ chains passing cairn Nos. 136 to 139 to cairn No. 140 at the north east corner of S. No. 175/1, thence westwards skirting survey Nos. 175/1 and 174/1, 173/1, 170/1 and 172/1 passing cairn Nos. 141 to 169 to cairn No. 170 (or cairn No. 62 of the Kariculum Reserve) at the north-western corner of the last mentioned survey number (172/1), thence westward along the north side of Survey No. 170/1 passing cairn No. 171 to cairn No. 172 (or cairn No. 60 of the Kariculum Reserve) at the tri-junction of Survey Nos. 790/1-1, 781/1 and 170/1.

West. Thence north-north east for about 3 chains along the east side of survey No. 790/1-1 to cairn No. 173, thence skirting the S. Nos. 790/1/1 and 790/17-B and passing cairn Nos. 174 to 177 to cairn No. 35 of Sethacal Extension Reserve at the north east corner of the latter survey number (790/17-B) thence north west along the eastern boundary of the same extension Reserve (i. e. along the east side of survey No. 790/1 for about 45 chains passing cairn Nos. 34, 33, 32, 31, 30 and 29 to cairn No. 28 of the above extension reserve at the south eastern corner of S. No. 803/1 thence north west skirting S. N. 803/1 and passing cairn Nos. 178 to 182 of the Sethacal Reserve to cairn No. 25 of the above extension reserve at the northernmost corner of the above survey number, thence more or less in the same direction along the east side of Survey No. 790/1 passing cairn Nos. 183 to 198 to cairn No. 199, thence north along the east side of the same survey number for about 20 chains passing cairn Nos. 200 to 203 to cairn No. 204, thence more or less north east along the east sides of S. Nos. 790/1 and 785/1 passing cairn Nos. 205 to 225 to cairn No. 226 at the south east corner of S. No. 785/2, thence along the east side of that survey No. to cairn No. 227 at its north east corner, thence northward along the east side of S. Boundaries.

North. Starting from cairn No. 1 at the northwestern corner of S. No. 781/2 of Ranni Pakuthi, the boundary runs more or less southeast along the north side of the above survey number passing cairn Nos. 2 to 9 to cairn No. 10 at the south western corner of S. N. 781/3, thence along the west, north, and east sides of the above survey number passing cairn Nos. 11 to 14 to cairn No. 15 at its south east corner, thence eastward along the north side of survey number 781/2 and 4 passing cairn Nos. 16 to 20 to cairn No. 21 at the north east corner of survey number 781/7.

East. Thence southward skirting S. Nos. 781/7 and 8 and passing cairn Nos. 22, 23, 23A, and 24 to cairn No. 27 at the Southernmost corner of the latter survey number.

South. Thence northward along the west side of S. Nos. 781/8 and 781/5 and passing cairn Nos. 28 and 28A to cairn No. 29 at the north west corner of the latter survey number, thence more or less west along the south side of S. No. 781/2 passing cairn Nos. 30 to 40 to cairn No. 41.

West. Thence northward along the western side of the above survey number passing cairn numbers 42 to 51 to cairn No. 52, thence east for about 8½ chains to cairn No. 53, thence north east for about 8 chains to cairn No. 1 at the starting point.

Access to this enclosure is granted by a path 10 links in breadth and about $11\frac{1}{2}$ chains in length. This path starts from cairn No. 215 on the western outer boundary of the Reserve and goes more or less in a north easterly direction and enters the enclosure at cairn No. 51 on its west side

Boundaries.

North. Starting from cairn No. 1 at the north west corner of survey No. 781/10, the line runs more or less east, along the north side of S. No. 781/10 and 781/9 passing cairn Nos. 2 to 13 to cairn No. 14 at the north east corner of the latter survey number.

East. Thence more or less south along the east side of survey No. 781/9 passing cairn Nos. 15 to 19 to cairn No. 20 at the south east corner of the above survey number.

South. Thence westward along the south side of S. No. 781/9 passing cairn Nos. 21 to 26 to cairn No. 27 at its south west corner.

West. Thence northward along the west side of S. No. 781/9 and south and west sides of S. No. 781/10 and passing cairn Nos. 28 to 37 to cairn No. 1 at the starting point.

Access to this enclosure is granted by a path 10 links in breadth and 24 chains in length. This path starts from cairn No. 27 of the enclosure A and goes more or less in a southerly direction and enters this enclosure (B) at cairn No. 6 on its north boundary.

N. B. Access to the path described above from the outer boundary is to be obtained by a right of way through the enclosure (A) since the enclosures (A) and (B) both belong to one and the same person.

North. Starting from Cairn No. 1 at the north west corner of S. No. 782/1 the line runs south east along the north side of that survey number passing cairns Nos. 2 to 15 to cairn No. 16 at its north east corner.

East. Thence south west along the east side of the above survey number passing cairn Nos. 17 and 18 to cairn No. 19 on its south west corner.

South. Thence westward along the south side of the above survey number passing cairn Nos. 20 to 32 to cairn No. 33 at its south west corner.

West. Thence northward along the west side of the above survey number (782/1. A & B) passing cairn Nos. 34 to 36 to cairn No. 1 at the starting point.

Access to this enclosure is granted by a path 10 links in breadth and about 29 chains in length. It starts from cairn No. 223 on the outer boundary of the Reserve and goes in a south easterly direction and enters this enclosure at its cairn No. 1.

South. Thence west north west along the south side of the above survey number for 6½ chains to cairn No. 4 at its south west corner.
