No. 176/1 of Peermade Village, Peermade Taluk.</p> <p><i>North:</i> Starting from cairn No. 1. situated on the north side of Kottayam Kumili Road and about 3 3/4 chains east of 2nd furlong stone 48th mile of the same road the line runs east north east for about 20¾ chains passing cairn Nos. 2 to 5 and crossing the foot- path to Churchill at cairn No. 5 to cairn No. 6, thence north east for about 4½ chains to cairn No. 7, thence east south east for about 14 chains passing cairn No.8 and 9 to cairns No.10 thence south east for about 6 chains to cairn No. 11.</p>	53.5acres

No. 176/1/38/1 is now excluded from the reserve between cairn Nos. 13 to 16 by altering the original outer boundary of the reserve.</p> <p>2. <i>Public rights admitted.</i> (a) The Kottayam Kumili road forms a portion of the western boundary of the Reserve at the 3rd furlong after 47th milestone and enters the reserve just north of cairn No. 28 and after running more or less in an easterly direction for about 4½ furlongs leaves the reserve north of cairn No. 17 on the eastern boundary of the reserve.</p> <p>(b) The bridle path leading to Church Hill branches off from the Kottayam Kumili Road at about 2 chains west of the 6th furlong stone after the 47th mile stone and goes north ward for about 5½ chains thence west ward for about 5 chains and leaves the Reserve west of the cairn No. 5 on the northern boundary.</p>	53.5 acres
