NOTICE.

SALE OF TREE-GROWTH IN THE PARALIAR COUPE FOR TEAK PLANTATION DURING 1097 WITHIN THE VIRAFELI RESERVED FOREST.

Notice is hereby given that the right or felling and removal of tree-growth standing in an area of 10% acres and 50 cents within the boundaries specified below for the Teak Plantage to be opened in 1097 will be sold in public auction by the Divisional Forest Officer, South Division at Vagarooil Depot on 12th Thulam 1696/28th Gotober 1920.

1. The austion will commence at 1 P. M.

2. Intending perchasers should deposit a sum of B. Ra. 102 (one hundred) only as earnes money before the auction commences without which nobody will be allowed to bid.

3. The purchaser should pay one-third of the amount bid for on the spot, failing which the earnest money deposited by him will be credited to Government and the right resold at his risk and loss, but he shall have no claim over the gain if any, which may accrue by such resale, to Government. He must pay the remaining two-thirds of the purchase money within seven days from date of communication of confirmation of the sale, failing which the one-

third amount paid by him will be forfeited to Government.

4. The sale will be confirmed subject to the approval of the Conservator of Forests in the name of the highest bidder, provided his character and financial status be found satisfactory. He shall execute an agreement in stamp paper within 15 days from the date of communication of the confirmation of the sale by the Conservator of Forests, binding himself to deliver the land well cleared, burnt and dressed so that it may be fit for planting purposes before the close of Medam 1097.

5. The earnest money of the unsuccessful bidders will be returned to them; while that of the successful bidder will be credited towards the one-third of the purchase money to

be paid by him.

6. The purchaser will be allowed to enter the coupe only after the execution of the agreement and obtaining a license from the Divisional Forest Officer. He may remove the timber either in logs, or materials or fuel or charcoal as he wishes covered by passes issued by the Divisional Forest Officer or the Officers deputed for the purpose by the Divisional Forest

## NOTIFICATION

3. The Divisional Forest Officer, Southern Division, is appointed the Forest Officer to attend on behalf of the Government, at the enquiry by the Forest Settlement Officer.
