In pursuance of the resolution of the Chief Justices' Conference, 1997, the High Court of Kerala has decided to adopt the categorisation and nomenclature of cases given in the table appended to this notification. The new categorisation and nomenclature of cases will take effect from 21/05/2003, the day when the High Court reopens after mid-summer vacation, 2003.
