**ORDER**

Consequent to the promulgation of the Rules read as 1<sup>st</sup> paper above, licenses issued by the Forest Department will become a statutory requirement for starting / operating sawmills and other wood based industrial units in the State. Presently No Objection Certificate for starting wood based industries are being issued by the State Level Empowered Committee with the concurrence of the Central Empowered Committee constituted by the Supreme Court of India in WP(C) 202/1995.

The Principal Chief Conservator of Forests in his letter read as 2<sup>nd</sup> paper above has requested Government to accord sanction for the realization of one time payment for the units started on or after 30.10.2002 at the rates indicated in the table below for issue of license and to deposit the amount in the bank account already opened in State Bank of Travancore, Vazhuthacaud branch, based on Government Orders in the name of the Principal Chief Conservator of Forests and Chairman of State Level Empowered Committee.

Sl.No.	Type of Units	Machineries	Amount of One Time Payment (₹)
1.	Furniture unit and other small scale units.	Wood working machines except saw having more than 5 HP capacity.	10,000/- per unit
2.	Sawmill / Packing Case / Block Board unit using exclusively rubber wood.	Saw and other machineries required for making packing case / block board except Peeler / Slicer / Press.	50,000/- per unit
3.	Veneer / plywood units.	Peeler / Slicer / Press and other machineries excluding saw above 5 HP.	2,00,000/- per Press / Slicer / Peeler

Government have examined the matter in detail and are pleased to accord sanction for the realization of One Time Payment for the units started on or after 30.10.2002 at the rates indicated by the Principal Chief Conservator of Forests in the letter read as 2<sup>nd</sup> paper above instead of provisions in the Kerala Forest Rules for issue of license and to deposit the amount in the bank account already opened in the name of the Chairman, State Level Empowered Committee.
