ORDER No.D1-85293/2019 dated: 03 -11-2020

Final seniority list of Range Forest Officers, as on 01.01.2011, was issued vide order read 1st above. Owing to the delay in the regularization of appointment of provisionally promoted Range Forest Officers under the FNTR category, seniority list of Range Forest Officers hadn't been revised thereafter. Now the appointment of provisionally promoted Range Forest Officers up to 31.12.2018 has been regularized. Meanwhile, most of the incumbents in the seniority list were either promoted or have retired from service. Newly recruited Range Forest Officers are also to be included in the seniority list. Hence, the existing seniority list has to be revised and a new provisional seniority list of Range Forest Officers is to be issued.

In the seniority list, Range Forest Officers, who are recruited as per notification issued based on Kerala Forest Subordinate Service Rules-1962, issued vide GO(Ms)No.652/62/PD, dated 29.11.1962 and Kerala Forest Service Special Rule-2010 issued vide GO(P)No.73/2010/F&WLD, dated 21.10.2010 are to be included.

Kerala Public Service Commission had issued separate notifications in 2008 based on the Kerala Forest Subordinate Service Rules-1962, for the recruitment of Range Forest Officers, under the categories, (i) Direct Recruitment from among candidates who possess a degree in Forestry, and (ii) Forest Apprentice from among candidates who possess a degree in Science or Engineering. Ten candidates under the Forest Apprentice category were recruited vide advice No.RIC(I) 15714/2019/GW dated 03.06.2009 and 21.08.2009. As per Rule 9(c) of Kerala Forest Subordinate Service Rules-1962, they had to complete Ranger's Course in the Forest Colleges and practical training for a period of one year in the Forest Department. After completing the Ranger's training and practical training, eight Range Forest Officers out of ten joined duty on 19.07.2011. One among them left the Forest Department service for better employment and the other Smt. Priya. R. Devi joined duty after practical training on 21.03.2018. While they were

undergoing training, the post of Range Forest Officer was included in Kerala Forest Service Special Rule which was amended vide Order (P)No.73/2010/F&WLD, dated 21.10.2010.

Twenty Five candidates under the category who possess a degree in Forestry were recruited as Range Forest Officers vide advice No.RIC(I) 32613/11/GW dated 30.11.2011 and 06.02.2012. The rule in force while they were recruited was Kerala Forest Service Special Rule-2010. As per rule 9(2)(a) of the Special Rule they were deputed for institutional training and practical training. After practical training twenty three Range Forest Officers out of twenty five reported for duty on 16.08.2014.

As Kerala Forest Service Special Rules 2010 doesn't prescribe the provisions for fixing the seniority of Range Forest Officers, the general rule will be applicable. Rule 27(c) of Kerala State and Subordinate Service Rule 1958 states "the seniority of a person appointed to a class, category or grade in a service on the advice of the commission shall, unless he has been reduced to a lower rank as punishment, be determined by the date of first effective advice made for his appointment to such a class, category or grade and when two or more persons are included in the same list of candidates advised, their relative seniority shall be fixed according to the order in which their names are arranged in the advice list."

The seniority of Range Forest Officers promoted from Deputy Range Forest Officers shall be determined with respect to the date of their appointment on promotion and their relative seniority position in the feeder category of Deputy Range Forest Officers on the date of promotion as provided in Sub Rule 27 (a) of Kerala State and Subordinate Service Rules and the explanation there under and on the basis of the decision in the Departmental Promotion Committee, if any, regarding fixing their relative seniority positions. Taking into account the above provisions, a provisional seniority list was prepared fixing the seniority of Range Forest Officers as on 01.01.2019.

Clarifications on fixing the seniority of the above categories of Range Forest Officers were sought from Government. A copy of the provisional seniority list was also furnished to the Government. Government vide order read 2nd above, has clarified that in the absence of provisions regarding fixing the seniority of Range Forest Officers in the Kerala Forest Service Special Rules 2010, the general rule would be applicable and that the provisional seniority list prepared on the basis of rule 27(c) of Kerala State and Subordinate Service Rule 1958 is in order. It is also observed that the candidates under Forest Apprentice category were advised two years before the Forestry Graduates.

Taking into account of the above facts and in compliance with the Government Order read 2nd above, the State wide seniority list of Range Forest Officers as on 01.01.2019 is appended to the order. The Range Forest Officers concerned are hereby required to prefer appeals, if any, against the provisional seniority list within three months from the date of publication in the Government Gazette with adequate justification in support of their claims along with the copies of the orders, if any, referred to in such appeals attested by their respective controlling officers. If no appeals are received within the time stipulated, the list will be finalized on the presumption that the incumbents concerned are in full acceptance of the list. Appeals received after the time limit will not be considered.


