The seniority of Sri.S.Mukundakumar has been re-fixed as 18 (A) in between Sl.No.18 Sri.George Francis and Sl.No19 Sri.A.Surendran in the seniority list of Junior Superintendents as on 01.11.2011 as per order read as 2nd above in order to implement the order dated 04.04.2014 in TA-3008/2012 (WP (c) No.37052/2004) of Honorable Kerala Administrative Tribunal.
