IFS -UPGRADATION OF EX-CADRE POST AND PROMOTION OF 1990,1991&1992 BATCH OF IFS OFFICERS TO CHIEF CONSERVATOR OF FORESTS-SANCTIONED -ORDERS ISSUED.

ORDER

The following IFS Officers of 1990, 1991 and 1992 batches are promoted to the grade of Chief Conservator of Forests in the scale of pay of Rs.37,400-67,000 plus grade pay Rs. 10,000/-

2. On Promotion

- (a) Smt. Prakriti Srivastava IFS (KL: 90) who is on Central Deputation as Deputy I.G of Forests, Forest Protection Division, MOEF is allowed to continue on Central Deputation .
- (b) Shri. D.Jayaprasad IFS (KL: 90), Conservator of Forests (Inspection & Evaluation), Kottayam is posted as Chief Conservator of Forests, (Working Plan & Research), Thiruvananthapuram in the existing vacancy.

(c) Shri. Noyal Thomas IFS (KL: 91) is allowed to continue as Chief Executive Officer, NORKA, ROOTS.

The Ex-cadre post of Chief Executive Officer, NORKA, ROOTS is upgraded to the grade of Chief Conservator of Forests in the scale of pay Rs. 37,400-67,000 plus grade pay of Rs. 10,000/- and is declared equivalent in status and responsibility to the cadre post of Chief Conservator of Forests (Social Forestry) as per Rule 9 of IFS (Pay) Rules 1968.

(d) Shri. S.Gopalakrishnan IFS (KL: 91) is allowed to continue as Managing Director, Rehabilitation Plantations Limited, Punalur, on State Deputation. The post of M.D, Rehabilitation Plantations Limited, Punalur is upgraded to the grade of Chief Conservator of Forests in the Scale of pay Rs. 37,400-67,000 plus grade pay of Rs. 10,000/- and is declared equivalent in status and responsibility to the cadre post of Chief Conservator of Forests (Social Forestry) as per Rule 9 of IFS (Pay) Rules 1968.

(e) Shri.E.Pradeep Kumar IFS (KL: 91), Conservator of Forests (Inspection & Evaluation), Kozhikode is posted as Chief Conservator of Forests, Tribal Mission in the existing vacancy with additional charge of Custodian EFL.

(f) Shri. Rajan Sehgal IFS (KL: 92) who is on Central Deputation as Senior Assistant Inspector General of Forests (RT) GOI is allowed to continue on Central Deputation .

3. Shri. Amit Mallick IFS (KL: 92) was not promoted to the grade of CF due to the pendency of the disciplinary action initiated against him. Later as per G.O.(Rt) No.326/12/GAD dated 10.01.2012, Shri Amit Mallick IFS was fully exonerated from the charges levelled against him. Hence Screening Committee found that he was eligible for promotion to the Conservator of Forests. The Screening Committee also cleared the officer for promotion to the grade of Chief Conservator of Forests along with his batch mates. As per the guidelines of promotion on conclusion of the disciplinary case/ criminal prosecution, sealed cover or covers shall be opened. In case the officer is completely exonerated, the due date of his promotion will be determined with reference to the findings of the Screening Committee kept in sealed cover/covers and with reference to the date of

promotion of his next junior on the basis of such findings. In this case Shri. Rajesh Ravindran, IFS (KL: 95) Junior to Shri.Amit Mallick IFS was not promoted to the grade of Conservator of Forests grade till this date.

4. Government have examined the matter in detail and sanction is accorded to promote Shri. Amit Mallick IFS (KL: 95) to the grade of Conservator of Forests notionally with effect from 10.01.2012 (date of Government Order dropping disciplinary action against him) and to promote him to the grade of Chief Conservator of Forests with effect from the date of this Government Order. On promotion to Chief Conservator of Forests grade, Shri.Amit Mallick, IFS is allowed to continue in the ex-cadre post of Director, Sports and Youth Affairs & CEO, National Games.

5. The ex-cadre post of Director, Sports & Youth Affairs &CEO, National Games is upgraded to the grade of Conservator of Forests for the period from 10.01.2012 to 21.05.2012 and is declared equivalent in status and responsibility to the cadre post of Conservator of Forests (I&E), Kottayam as per Rule 9 of IFS (Pay) Rules 1968.

6. For the period from 22.05.2012, the ex-cadre post of Director, Sports & Youth Affairs & CEO, National Games is upgraded to the grade of Chief Conservator of Forests and is declared equivalent in status and responsibility to the cadre post of Chief Conservator of Forests (Social Forestry) as per Rule 9 of IFS (Pay) Rules 1968.

7. The promotion are ordered with the concurrence of Government of India as stipulated under Rule 3(2)(ii) & (iii) of IFS (Pay) Rules 2007, vide the letter read as 1st paper above.
