In exercise of the powers conferred by Section 3 of the Kerala State Right to Service Act, 2012 (18 of 2012), the Government of Kerala have notified the services rendered to public and the details of designated officers, stipulated time limit, the first appellate authority and the second appellate authority in respect of

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Section 3 of the Kerala State Right to Service Act, 2012 (18 of 2012) empowers the Government to notify the services in each Department that will be rendered to public and the details of designated officers, stipulated time limit, first appellate authority and second appellate authority. In accordance with the provisions of the said section, a notification was issued under the G.O. (P) No.116/2012/F&WLD. dated 7th December, 2012 and published as S.R.O No.851/2012 in the Kerala Gazette Extraordinary No.1415 dated 10th December, 2012. Now the Government have decided to make amendment to the said notification in order to incorporate one item of service also to that notification.

The notification is intended to achieve the above object.
