On the subject cited above it is mentioned that by Prevention of Money-Laundering (Amendment) Act 2012, the offences against the Wildlife Protection Act, 1972 have been brought under Paragraph-6 of Part-A of the Schedule of the principle Act i.e. "The Prevention of Money Laundering Act, 2002." Hence, all the offences listed under Paragraph-6 (Copy enclosed) are scheduled offences in terms of section 2(i) (y) of the PML Act, and action to confiscate the properties/proceeds derived from the wildlife crime can be initiated under the said Act.

In exercise of the powers conferred by sub-section (2) of section 1 of the Prevention of Money-Laundering (Amendment) Act, 2012 (2 of 2013), the Central Government hereby appoints the 15th day of February, 2013, as the date on which the provisions of the said Act shall come into force.

PREAMBLE

An Act further to amend the Prevention of Money-laundering Act, 2002.

Be it enacted by Parliament in the Sixty-third Year of the Republic of India as follows:--

Section 1 - Short title and commencement

- (1) This Act may be called the Prevention of Money-laundering (Amendment) Act, 2012.
- (2) It shall come into force on such $\frac{1}{2}$ date as the Central Government may, by notification in the Official Gazette, appoint.

It is clarified that in terms of Section 2(1)(y) of the Prevention of Money Laundering Act, 2002; a Scheduled offence means the offences specified under Part B of the Schedule if the total value involved in such offences is thirty lakh rupees or more; or the offences specified under Part C of the Schedule i.e. Part B offences involving cross border (Trans national) implications.
- 3. It is also requested that in future monthly information on such offences registered under your jurisdiction may be sent to this Bureau on the formats enclosed herewith as ML I and ML II, please.
